Commission to hold hearings on any Applications received for

struction or operation of a pay-television undertaking; and

WHEREAS the Commission issued a public notice  
advising of the terms of reference of Order-in-Council No.  
193; and

WHEREAS Robson Valley Cable Systems applied for  
a Certificate of Public Convenience and Necessity by an  
Application dated July 20, 1982; and

WHEREAS the Application was heard by the Commis-  
sion in Vancouver on August 25, 1982.

NOW THEREFORE the Commission orders as follows:

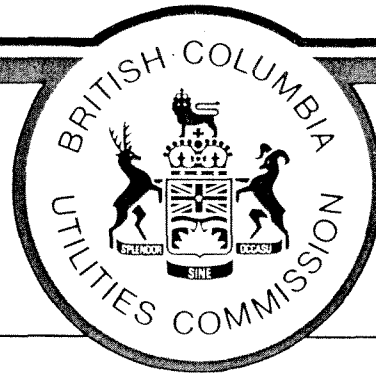
1. Certificate of Public Convenience and Necessity No. T-11-82 issue to Robson Valley Cable Systems covering the ownership, construction and operation of a pay-television undertaking serving an area encompassing McBride, Tete Jaune and Valemount, British Columbia, all as more particularly described in the Application and hearing record, subject to the following condition:
  - (a) The service offered by the undertaking must be provided at the rates and under the terms of service described in the Application and the hearing record.
2. A complaint which the Commission finds is related to a matter which may be in contravention of the guidelines for enforcement of the obscenity provisions, Criminal Code of Canada may be referred to the Attorney General for investigation and the Commission may suspend the Certificate until such matter is concluded.
3. No variation or alteration in the Certificate of Public Convenience and Necessity or this Order may be made without the approval of the Commission first obtained.
4. This Certificate will expire if Robson Valley Cable Systems has not commenced the operation of the said pay-television undertaking prior to December 31, 1983.
