WHEREAS the Lieutenant Governor in Council issued Order-in-Council No. 193 February 1, 1982 and directed the Commission to hold hearings on any Applications received for a Certificate of Public Convenience and Necessity for the construction or operation of a pay-television undertaking; and

WHEREAS the Commission issued a public notice advising of the terms of reference of Order-in-Council No. 193; and

WHEREAS Interior Industries Inc. applied for a Certificate of Public Convenience and Necessity by an Application dated July 16, 1982; and

WHEREAS the Application was heard by the Commission in Vancouver on August 25, 1982; and

WHEREAS the Applicant commenced the operation of a pay-television undertaking in Revelstoke and District in May, 1980.

NOW THEREFORE the Commission orders as follows:


1. Certificate of Public Convenience and Necessity No. T-6-82 issue to Interior Industries Inc. covering the ownership and operation of a pay-television undertaking serving Revelstoke and District, all as more particularly described in the Application and hearing record, subject to the following condition:
 - (a) The service offered by the undertaking must be provided at the rates and under the terms of service described in the Application and hearing record.
2. A complaint which the Commission finds is related to a matter which may be in contravention of the guidelines for enforcement of the obscenity provisions, Criminal Code of Canada may be referred to the Attorney General for investigation and the Commission may suspend the Certificate until such matter is concluded.
3. No variation or alteration in the Certificate of Public Convenience and Necessity or this Order may be made without the approval of the Commission first obtained.
