WHEREAS Columbia Natural Gas Limited ("CNG") applied November 10, 1986 pursuant to Section 67(4) of the Utilities Commission Act ("the Act") to amend its Tariff Rate Schedules in its Gas Tariff B.C.U.C. No. 1 covering the rates to be charged effective November 1, 1986 for natural gas service rendered by the Company in its service area; and

WHEREAS CNG's Application reflects changes arising from the following:

1.	Federal and Provincial governmental policies
	concerning the competitive marketing of natural gas;
2.	renegotiated gas prices with Columbia's gas suppliers;

3. reductions in Municipal Franchise Fees, plus related costs; and

WHEREAS the Commission has reviewed the Application and supporting material and finds that the filing of amendments to the filed Tariff Rate Schedules is necessary in the public interest.
