## ORDER

WHEREAS Pacific Northern Gas Ltd. ("PNG") applied December 17, 1986 pursuant to Section 67(4) of the Utilities Commission Act ("the Act") to amend its Tariff Rate Schedules in its Gas Tariff B.C.U.C. No. 3 covering the rates to be charged effective November 7, 1986 for natural gas service rendered by the Company in its service area; and

WHEREAS PNG'S Application reflects the requirements of Commission Order No. G-77-86 which include revised arrangements for the operation of the Ocelot Methanol Plant and the Ocelot Ammonia Plant during the period November 7, 1986 through October 31, 1988; the adoption of "flow-through" Income Tax Accounting during the same period; and an amendment of the Gas Supply Agreement between Pacific Northern Gas Ltd. and the British Columbia Petroleum Corporation ("B.C.P.C."); and

WHEREAS the Commission has reviewed the Application and supporting material and finds that the filing of amendments to the filed Tariff Rate Schedules is necessary in the public interest.
