O R D E R

WHEREAS ICG Utilities (British Columbia) Ltd. ("ICG")
applied October 28, 1986 to amend its filed Tariff Rate Schedules
in its Gas Tariff B.C.U.C. No. 2, covering the rates to be charged
for natural gas service rendered by the Company in the Fort St.
John District; and

WHEREAS the initial amendment is to permit ICG to
decrease its Tariff Rate Schedules as a result of a decrease,
effective November 1, 1986, in the cost of natural gas purchased
from its supplier, and related costs, equivalent to 34.2 cents/GJ
for the Residential and Commercial core market, and 60.0 cents/GJ
for the Industrial market; and

WHEREAS an additional amendment is to permit ICG to
recover over 24 months from November 1, 1986 increased costs
related to attendance at a National Energy Board hearing related
to Westcoast Transmission Company Limited ("Westcoast") tolls,
equivalent to 2.60 cents/GJ for all classes of service; and

WHEREAS the Commission has reviewed the Application
and supporting material and finds that the filing of the
amendments to the filed Tariff Rate Schedules is necessary in the
public interest.


