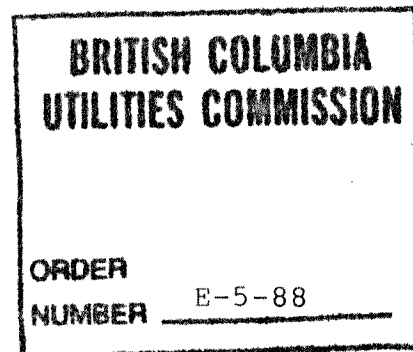

O R D E R

WHEREAS amendments to the Utilities Commission Act ("the Act"), including Section 85.3, requires that Energy Supply Contracts ("Contracts") between producers and consumers, be filed with the Commission for approval; and

WHEREAS on August 18, 1988 the Commission issued Rules for filing of such Contracts; and

WHEREAS Inland Natural Gas Marketing Ltd. ("INGM") has filed with the Commission draft natural gas supply contracts between the Company and its small industrial clients, being; Ainsworth Lumber Co. Ltd., B.C. Forest Products - Williams Lake Division (Pinette & Therrien Mills), Brenda Mines Ltd., Federated Co-Operative Limited, Hiram Walker & Sons Limited, Pope & Talbot Ltd., Prince George Wood Preserving Ltd., Quesnel Forest Products - A Division of Slocan Forest Products Ltd., Sun-Rype Products Ltd., Tolko Industries Ltd., Weldwood Canada Ltd., West Fraser Mills Ltd., and Westar Timber Ltd. and your suppliers Quintanna Exploration Canada Ltd., Canterra Energy Ltd. and Petro-Canada Inc. ("Quintanna, Canterra, Petro-Can") for the period commencing November 1, 1988 to October 31, 1990 inclusive under Rules - Section 1.2.3; and



WHEREAS the Commission has reviewed the proposed draft Contracts and supporting material and is satisfied that it is in the public interest.

NOW THEREFORE pursuant to Section 85.3 of the Act, the Commission orders as follows:

1. The Commission approves and accepts for filing the draft Energy Contracts between INGM and Quintanna, Canterra, Petro-Can dated November 1, 1988 which are designated as Energy Supply Contracts, NGSC No. 5.
2. INGM is to file with the Commission a fully executed set of Energy Supply Contracts on or before November 30, 1988.
