ORDER

WHEREAS British Columbia Hydro and Power Authority ("B.C. Hydro") applied December 21, 1987 for Commission approval of the continuance to include in its operating expenses for its electric service until June 30, 1988 the payment by B.C. Hydro to Yoho Power Ltd. ("Yoho") of money for the purpose of providing a subsidy to Residential consumers of electricity in the community of Field, B.C. who are served by Yoho; and


WHEREAS the Commission has reviewed the Application and has determined that the payment of the subsidy requested is in the public interest.

NOW THEREFORE the Commission hereby orders B.C. Hydro as follows:

1. The Commission approves the subsidy payment by B.C. Hydro to Yoho Power Ltd. applicable to Residential consumers only, for the period September 29, 1987 through June 30, 1988, calculated on the difference between the existing rate of 21.55 cents/kWh as set forth in Yoho's Electric Tariff Rate Schedule FLD-01 applicable to the first 550 kWh per month actual consumption and 7.50 cents per kWh.
2. Commission Order No. G-57-87 is rescinded.
