## ORDER

WHEREAS on January 7, 1988 Inland Natural Gas Co. Ltd. ("Inland") applied for Commission approval and acceptance for filing effective January I, 1988 of amendments to its Gas Tariff Rate Schedules, and the establishment of certain deferral accounts, resulting from a November, 1987 National Energy Board Decision on Westcoast Transmission Company, Limited ("Westcoast") Tolls; and

WHEREAS the Westcoast Tolls involve the following:

- 1. For the Calendar Year ended December 31, 1987:
  - (a) Interim Westcoast Toll charges currently incorporated in Inland's rates to be made permanent;
  - (b) Any additional changes in 1987 Westcoast Tolls to be deferred.
- 2. Effective January 1, 1988:
  - (a) Westcoast 1988 Toll changes to be flowed through on an estimated net Toll basis:
  - (b) The difference between the estimated and actual Westcoast Tolls to be deferred; and

WHEREAS on January II, 1988 Inland applied for Commission approval and acceptance for filing of amendments to its Gas Tariff Rate Schedules reflecting changes to Atmospheric Pressure Reduction (APR) factors in accordance with revisions in the regulations pursuant to the Electric and Gas Inspection Act of Canada; and

WHEREAS the Commission has reviewed the Applications and supporting material and is satisfied that the amendments are appropriate and in the public interest.

NOW THEREFORE the Commission orders Inland Natural Gas Co. Ltd. as follows:

- l. Approval is granted effective January I, 1988 to the amendments as proposed concerning Westcoast Tolls and APR factor changes.
