O R D E R

WHEREAS Commission Order No. G-72-88 set down the Applications to Consolidate Inland Natural Gas Co. Ltd. ("Inland"), Columbia Natural Gas Limited ("Columbia") and Fort Nelson Gas Ltd. ("FNG"), for a public hearing to commence on October 12, 1988 at Kamloops, B.C.; and

WHEREAS Inland, Columbia and FNG applied by letter dated September 23, 1988 for the Applications to be withdrawn; and

WHEREAS the Commission has considered all of the above.

NOW THEREFORE the Commission orders Inland, Columbia and FNG as follows:

1. The Application to withdraw the Applications to Consolidate is approved.
2. Inland, Columbia and FNG will arrange for publication of Notice of Cancellation of Public Hearing, not later than October 5, 1988, as per attached copy in one issue of the Vancouver Sun and Province and other local newspapers and publications as may properly provide adequate public notice in the general service areas of the companies.
3. Inland, Columbia and FNG will advise all Registered Intervenor and Interest Parties on or before October 7, 1988 that the Application to Consolidate has been withdrawn by the Companies and was subsequently approved by Commission Order No. G-92-88.



NOTICE OF CANCELLATION OF PUBLIC HEARING

THE APPLICATIONS

Inland Natural Gas Co. Ltd. ("Inland"), Columbia Natural Gas Limited ("Columbia") and Fort Nelson Gas Ltd. ("FNG"), applied to the Commission for an Order of the Lieutenant Governor in Council consenting to the consolidation of Inland, Columbia and FNG to be effective December 31, 1988.
