- 6. Agreement regarding the Sale and Purchase of a Short Term Firm Gas Supply dated as of the first day of December, 1991 with Questar Energy Company for a contract demand of 177.7 10<sup>3</sup>m<sup>3</sup>/day covering the term ending March 1, 1992.

Amendment dated October 28, 1991 to the Five Year Natural Gas Sales Agreement dated August 10, 1989 with Unocal Canada Limited as amended by letter agreements dated May 31, 1990, January 18, 1991, January 29, 1991, February 13, 1991 and March 6, 1991 for a contract demand of 708 10<sup>3</sup>m<sup>3</sup>/day covering the term ending March 31, 1994.
