ORDER

WHEREAS:

- A. On August 14, 1991 BC Gas Inc. Lower Mainland Division ("BC Gas") applied to the Commission for approval of Tariff Supplement No. 28 Agreement for gas service to Squamish Gas Co. Ltd., ("Squamish Gas") covering the period August 6, 1991 to November 1, 1991 at prices paid for gas by the Lower Mainland Division and as outlined in Article 6; and
- B. On October 31, 1991 BC Gas applied to the Commission for approval of amendments to Tariff Supplement No. 28 for gas service to Squamish Gas covering the period November 1, 1991 to November 1 2001 at forecasted prices paid for gas by the Lower Mainland Division and as set out in Article 6; and
- C. The Agreements covered by Tariff Supplement No. 28 require gas to be transported over the Pacific Coast Energy Corporation ("PCEC") transmission pipeline to Squamish from the interconnection of the Westcoast Energy Inc. and BC Gas systems at Huntingdon to the interconnection of the Squamish Gas and PCEC systems; and
- D. On August 11, 1992 the Ministry of Energy, Mines and Petroleum Resources ("MEMPR") advised Squamish Gas that certain amendments to Articles 6.1 and 9.1 were required in the Gas Supply Agreements with BC Gas with respect to the Squamish Rate Stabilization Agreement; and
- E. The Commission has reviewed the Agreements, including the required MEMPR amendments, and finds that approval is necessary and in the public interest.

NOW THEREFORE the Commission orders as follows:

The Commission approves and accepts for filing for BC Gas - Gas Tariff, Tariff Supplement No. 28, Gas Supply Agreement between BC Gas and Squamish Gas as follows:

- 1. Agreement covering the period August 6, 1991 to November 1, 1991
 - Original Sheets No. 28-1 to 28-4 and 28-7 to 28-10 inclusive.
- 2. Agreement covering the period November 1, 1991 to November 1, 2001
 - First Revision of Sheets No. 28-1 to 28-4 and 28-7 to 28-10 inclusive.
- 3. BC Gas is required to amend Original and First Revision of Sheets No. 28-5 and 28-6 in both Gas Supply Agreements of Tariff Supplement No. 28 in order to account for amendments required by the August 11, 1992 letter from the MEMPR.

The Commission approves and accepts for filing for Squamish Gas the Gas Supply Agreements with BC Gas covering the period August 6 to November 1, 1991 and November 1, 1991 to November 1, 2001, subject to the filing of the required amendments to Article 6.1 and 9.1, pursuant to the Commission's Rules and Section 85.3 of the Act.
