### AN ORDER IN THE MATTER OF the Utilities Commission Act, S.B.C. 1980, c. 60, as amended

and

An Application by Centra Gas British Columbia Inc.

### WHEREAS:

- A. Commission Order No. E-10-91 approved for Centra Gas British Columbia Inc. ("Centra Gas") long-term natural gas contracts with Encor Energy Corporation Inc., Ocelot Industries Ltd. and Petro-Canada ("the Suppliers") pursuant to Rules Respecting Energy Supply Contracts ("the Rules") and Section 85.3 of the Utilities Commission Act ("the Act"); and
- B. On December 15 and 22, 1992 Centra Gas applied to the Commission for approval of amendments to pricing arrangements under the long-term gas supply contracts with the Suppliers effective with the gas contract year commencing November 1, 1992; and
- C. Centra Gas also applied for approval of prices for fuel gas purchased commencing November 1, 1991 from the long-term gas supply contracts with the suppliers for delivery to Westcoast Energy Inc. ("WEI") as fuel gas required for transportation on its system; and
- D. The Commission has reviewed the pricing arrangements under the Contracts with the Suppliers and is satisfied that its approval should be given.

**NOW THEREFORE** pursuant to Section 85.3 of the Act and the Rules thereunder, the Commission orders as follows:

- 1. The pricing arrangements between Centra Gas and the Suppliers, as outlined in Appendix A to this Order, effective for the gas contract year commencing November 1, 1992 are approved.
- 2. The prices commencing November 1, 1991 for fuel gas supplied to WEI, as outlined in Appendix A to this Order, are approved.
- 3. Centra Gas will file fully executed amendments dealing with the foregoing price changes in a timely fashion.

- 3. Ocelot Energy Inc. ("Ocelot") letters dated September 15, and October 15, 1992 and CHMI letter dated October 14, 1992 establishing price for fuel gas under the two Gas Purchase Agreements between Ocelot and Centra Gas dated April 24, 1991.
