WHEREAS:

- A. Centra Gas British Columbia Inc. ("Centra Gas") filed for Commission approval Industrial Gas Sales Agreements and General Terms and Conditions ("the Agreements") for natural gas service under the Competitive Range Rate Class for the following: Capital City Paving Ltd., Camosun College, Cumberland Wood Industries Ltd., Island Asphalt Ltd., University of Victoria, Nanaimo General Hospital, Rebco Wood Products Ltd., and Bill Smith Forest Products Ltd.; and
- B. As a result of changes to the Net Book Value provision in the Contract dated August 31, 1992 for Capital City Paving, which was approved by Commission Order No. G-86-92, the Agreement was renegotiated and resubmitted for approval; and
- C. The Commission has reviewed the Agreements and finds that approval is necessary and in the public interest.

NOW THEREFORE the Commission orders as follows:

1. The Commission approves Industrial Gas Sales Agreements including General Terms and Conditions under the Competitive Range Rate Class between Centra Gas and the following:
