WHEREAS:

- A. On September 12, 1994, a public hearing commenced at Vancouver, B.C. into the British Columbia Hydro and Power Authority ("B.C. Hydro") February 12, 1994 Application for its 1994/95 Revenue Requirements; and
- B. Participants to the public hearing submitted applications for costs related to their participation; and
- C. The Panel discussed the claims having regard to the criteria and rates set out in Order No. G-117-93 and provided the awards to be added to the Participant Funding sheets. Although the Hearing lasted thirteen days, it was decided to add one day to the participant allowances to account for written argument; and
- D. The awards to Counsel were based on \$800 per participation-day plus expenses which the Panel felt was a reasonable amount for legal costs; and
- E. The awards to Consultants were based upon the fee and expense schedules submitted; and
- F. The Commission has reviewed the Participant Funding applications and requires B.C. Hydro and Power Authority to pay for such awards as outlined below. A breakdown of the cost awards can be found in the Participant Funding Sheet attached as Appendix A to this Order.
