WHEREAS:

- A. On November 1, 1993 The Yukon Electrical Company Ltd. ("YECL") applied to the British Columbia Utilities Commission ("the Commission") for exemption from the provisions of the Utilities Commission Act ("the Act"), in respect of the supply of wholesale power to the Dease River Indian Band located at Good Hope Lake, B.C.; and
- B. There is no other electrical generation facility in the area; and
- C. The Dease River Indian Band, YECL and the Department of Indian and Northern Affairs have entered into a mutually agreeable contract for the supply of electrical generation; and
- D. The Commission has considered the Application and is satisfied that an Order exempting YECL from certain sections of the Act properly conserves the public convenience and interest; and
- E. On February 24, 1994 the approval of the Lieutenant Governor in Council was given to the said exemption by Order in Council No. 0232, 1994; and
- F. The Commission may, pursuant to Section 114 of the Act, reconsider, vary or rescind an Order made by

NOW THEREFORE the Commission orders as follows:

The sale of power by YECL to the Dease River Indian Band at Good Hope Lake, B.C. is exempt from the Act, other than Part 2 and Section 114.
