1994/95 Revenue Requirements - Participant Funding Cost Awards

The hearing panel to the West Kootenay Power Ltd. hearing has considered your June 2, 1994 request for reconsideration of the Participant Funding Award. Please note that Section 133.1(1) of the Utilities Commission Act ("UCA") states that:

"The Commission may order a participant in a proceeding before the Commission to pay all or part of the costs of another participant in the proceeding." (emphases added)

The legislation does not oblige the Commission to cover all, or any part of the costs of participants in a proceeding and the Commission has established a funding policy that was discussed and approved by the West Kootenay Power Ltd. hearing panel in the determination of the cost award to you.

The Commission therefore declines to reconsider Order No. F-6-94.
