- A. On April 7, 1995 British Columbia Hydro and Power Authority ("B.C. Hydro") applied to the Commission for approval of amendments to the Short-Term Natural Gas Sales Contract dated September 10, 1992 with CanWest Gas Supply Inc. ("CanWest"), and two amendments to the Interruptible Gas Purchase Agreement dated March 11, 1993 with Inland Pacific Energy Services Ltd. ("Inland") for interruptible service covering the month of March, 1995. B.C. Hydro also applied for approval of amendments to Firm Gas Contracts dated March 11, 1993 with Inland, and September 28, 1994 with Westcoast Gas Services Inc. ("WGSI") covering the period April 1 to 30, 1995; and
- B. B.C. Hydro also applied on April 7, 1995 for approval of a procedure for making monthly and daily gas purchases on the spot market along with the proposed monthly reporting of such purchases.
- C. The Commission has reviewed the application and filings and is satisfied that the contract amendments and spot gas purchasing and reporting procedures should be approved.
