ORDER

WHEREAS:

- A. On November 14, 1995 the British Columbia Hydro and Power Authority ("B.C. Hydro") filed its Wholesale Transmission Services Application ("the Application") and requested approval of its rates and terms and conditions of service, on an interim basis, by January 31, 1996; and
- B. By Order No. G-97-95 the Commission set the Application down for public hearing and determined a regulatory schedule of deadlines; and
- C. A pre-hearing conference was held on December 14, 1995 during which the Applicant and other interested parties requested amendments to the public hearing date and schedule of timing deadlines for the Application and suggested alternative dates. In addition, parties were canvassed about their views with respect to the acceptability of an interim rate as requested in the Application; and
- D. The Commission has reviewed the proposed dates for the Application and agreed to the following changes.

NOW THEREFORE the Commission orders B.C. Hydro as follows:

- 2. All parties wishing to intervene in the Application are requested to give notice in writing to the Commission Secretary not later than January 2, 1996.
- 3. All parties intending to apply for Participant Funding must file a budget by January 2, 1996, instead of December 22, 1995 as set out in Order No. G-97-95. The budget must be consistent with the Commission's Policy and Rate Sheet as outlined in Order No. G-117-93. Copies of the Participant Funding Policy and Rate Sheet are available upon request.
- 4. Approval of the Application on an interim basis is granted effective January 31, 1996. The interim rates shall remain in effect until the date of the Commission's Decision with respect to this Application. Effective the date of the Commission's Decision, rates for existing and future transactions under this tariff will be as set out in the Decision.
- 5. B.C. Hydro will publish, in display-ad format, the attached Notice of Public Hearing in the business sections of The Vancouver Sun and The Province newspapers, and in local newspapers in the affected service areas as soon as can be arranged.

BRITISH COLUMBIA HYDRO AND POWER AUTHORITY WHOLESALE TRANSMISSION SERVICES APPLICATION

THE APPLICATION

The British Columbia Hydro and Power Authority ("B.C. Hydro) has applied to the Commission for approval of Wholesale Transmission Services rates. The Commission approved interim rates effective January 31, 1996 by Order No. G-109-95.

A public hearing into the Application is set down for Monday, March 4, 1996 at 8:30 a.m. in the Commission's Hearing Room, 6th Floor, 900 Howe Street, Vancouver, B.C., V6Z 2N3.

SUBMISSIONS BY INTERVENORS

PARTICIPANT FUNDING

All parties intending to apply for Participant Funding must first register with the Commission and obtain the new guidelines for participant funding. All parties must then file a budget by January 2, 1996 consistent with the Commission's Rate Sheet as outlined in Order No. G-117-93.
