ORDER

WHEREAS:

- A. On April 28, 1995 Kanelk Transmission Company Limited ("Kanelk") applied to the Commission for approval of rates on an interim basis, pursuant to Section 106 of the Utilities Commission Act ("the Act"), and on a permanent basis pursuant to Section 64 of the Act, for transmission and other services provided by or through Kanelk to British Columbia Hydro and Power Authority ("B.C. Hydro") effective June 1, 1995; and
- B. The Commission, by Order No. G-45-95, approved interim rates for Kanelk for transmission and other services and set the Application down for public hearing to commence September 6, 1995, in Vancouver, B.C.; and
- C. As a result of Pre-hearing Conferences held on June 19, 1995 and August 23, 1995 the Commission rescheduled the public hearing, restricting it to the arguments as to its jurisdiction over the Application and B.C. Hydro's motion for adjournment of the date for commencing the hearing, and issued Order No. G-69-95; and
- D. The public hearing was held on September 5, 1995 and the Commission's Decision is issued concurrently with this Order.
- E. The Commission concludes that the Kanelk service to B.C. Hydro is not an interprovincial undertaking and falls within the jurisdiction of the Commission.

- 1. The Commission will not rescind or vary Order No. G-45-95, dated May 18, 1995, which approved rates on an interim basis, subject to refund with interest, pending the outcome of the public hearing into Kanelk's Application.
- 2. A public hearing into rates and charges will commence Monday, September 18, 1995 at 8:30 a.m. in the Commission's Hearing Room, 6th Floor, 900 Howe Street, Vancouver, B.C. V6Z 2N3.
