by November 22, 1996.

their intention to intervene and/or attend the Pre-Hearing Conference.

3. PNG is to provide a copy of this Order, by facsimile if possible, to all 1995 Registered Intervenors and

Interested Parties, as well as all Industrial Customers as soon as possible.

4. Following the results of the Pre-Hearing Conference, the Commission will issue an Order outlining

further steps and a regulatory timetable to be followed for the review of the Application.
