## ORDER

## WHEREAS:

- A. On October 29, 1996 ECNG Inc. ("ECNG") applied to the Commission for renewal of an Agents/Brokers/Marketers Licence ("A/B/M Licence") for the period ending October 31, 1997; and
- B. The Application was made pursuant to the Commission's March 11, 1993 Decision on Domestic Natural Gas Supply Rules which requires that any person intending to act in the capacity of an Agent/Broker/Marketer to provide advice to, or act on behalf of, core market consumers purchasing gas directly in the Province of British Columbia, obtain an A/B/M Licence from the Commission; and
- C. On December 5, 1996 ECNG confirmed that the Irrevocable Standby Letter of Credit dated October 30, 1995 with the Royal Bank of Canada was extended for a further one year term. The Letter of Credit, in the amount of \$250,000, is to be used to guarantee the performance of ECNG's gas supply contracts; and
- D. The Commission has reviewed the Application by ECNG and, relying upon the information and representations made by ECNG contained in the Application, finds that approval of an A/B/M Licence, subject to conditions, is required.

NOW THEREFORE the Commission orders as follows:

- 1.0 The Commission issues to ECNG an A/B/M Licence for the period up to and including October 31, 1997.
- 2.0 The A/B/M Licence is issued subject to the following conditions:
  - 2.1 ECNG will carry out the undertakings set out in Section 19 of its October 29, 1996 Application;
  - 2.2 ECNG will comply with the approved A/B/M Code of Conduct;
  - 2.3 ECNG will maintain the Performance Bond in full force and effect for the duration of the A/B/M Licence;
