ORDER

WHEREAS:

- A. On September 30, 1995 the British Columbia Hydro and Power Authority ("B.C. Hydro") filed its preliminary 1995 Integrated Resource Plan ("the IRP"); and
- B. On November 6, 1995 B.C. Hydro filed the final 1995 IRP with Appendices; and
- C. On December 15, 1995 the Commission issued a timetable for the review of the B.C. Hydro IRP, including a provision for Information Requests to B.C. Hydro; and
- D. The Independent Power Association of British Columbia ("IPABC") made Information Requests to B.C. Hydro with respect to the IRP; and
- E. By way of letter dated February 7, 1996 (amended by letter dated February 9, 1996), the IPABC complained that B.C. Hydro had failed to provide full and complete answers with respect to Questions 1.1, 1.2, 1.3, 1.4, 1.5, 2.3 and 3.1 and requested that the Commission order B.C. Hydro to do so; and
- F. By way of letter dated February 9, 1996 B.C. Hydro presented argument as to why such an Order should not be issued; and
