## ORDER

## WHEREAS:

- A. On March 4, 1996 Centra Gas British Columbia Inc. ("Centra Gas") applied to the Commission for approval of pricing amendments for the 1995/96 gas contract year under the November 1, 1986 contract with Westcoast Gas Services Inc. ("WGSI") for the supply of gas to the Fort St. John Division; and
- B. On March 12, 1996 Centra Gas applied to the Commission for approval of winter peaking and seasonal gas supply arrangements with WGSI for the 1995/96 gas contract year for the Fort St. John and VIGAS Divisions; and
- C. On March 15, 1996 Centra Gas applied to the Commission for approval of a winter seasonal gas supply agreement with Mobil Oil Canada Ltd. ("Mobil") for the 1995/96 gas contract year for the VIGAS area; and
- D. The Commission has reviewed the Agreements and is satisfied that approval is necessary and in the public interest.

**NOW THEREFORE** pursuant to Section 85.3 of the Utilities Commission Act and the Rules, the Commission approves the following amendments and Agreements for Centra Gas:

- 1. Winter Seasonal Agreement dated November 14, 1995 with Mobil for up to 5,500 GJ/d for the VIGAS Division.
- 2. Winter Seasonal Agreement dated October 30, 1995 with WGSI for 3,500 GJ/d for the VIGAS Division.
- 3. Winter Seasonal Agreement dated October 30, 1995 with WGSI for 7,000 GJ/d for the Fort St. John Division.
- Letter Agreement dated February 9, 1996 which establishes prices for 1995/96 under the Baseload Gas Purchase Contract with WGSI dated November 1, 1986 for 340.0 10<sup>3</sup>m<sup>3</sup>/d (12,700 GJ/d) for the Fort St. John Division.
