O R D E R

WHEREAS:

- A. The Commission, by Order No. G-6-97, set down a public hearing into the issue of Retail Access and Unbundled Tariffs to commence April 1, 1997 in Vancouver, B.C. The Order also set out deadlines for submissions, information requests and requests for participant assistance from Intervenor; and
- B. Following a March 26, 1997 request from the Minister of Employment and Investment the Commission, by Order No. G-41-97, adjourned indefinitely the April 1, 1997 public hearing. The Commission requested applications for participant assistance cost awards to be filed with the Commission by May 16, 1997; and
- C. The Commission received seven (7) applications for participant assistance costs awards relating to the adjourned public hearing into Retail Access and Unbundled Tariffs; and
- D. The Commission discussed the participant cost assistance claims having regard to the criteria and rates set out in Order No. G-103-96; and
- E. The Commission has determined that preparation time for the registered Intervenor requires reimbursement in accordance with approved guidelines.

NOW THEREFORE the Commission orders as follows:

1. Pursuant to Section 118(1) of the Utilities Commission Act the Commission orders British Columbia Hydro and Power Authority ("B.C. Hydro") and West Kootenay Power Ltd. ("WKP") to reimburse participants in the total amount of \$146,035.14. The allocation of participant costs is based on the pro-rata energy sales for the previous calendar year as published in the Commission's 1996 Annual Report to the Legislature.
