WHEREAS:

- A. On November 24, 1997, Centra Gas British Columbia Inc. ("Centra Gas") applied, pursuant to Section 60 of the Utilities Commission Act and the Special Direction issued by the Lieutenant Governor in Council through Order In Council No. 1510 dated December 13, 1995, to change rates for New Customers, effective January 1, 1998 ("the New Customer Rate Application"); and
- B. The Special Direction directs the Commission on the fixing of New Customer rates up to 2002 and allows an increase of up to 6 percent in New Customer rates, effective January 1, 1998; and
- C. Centra Gas proposes to change the basic monthly charge and the energy charge for New Customers which results in changes to the annual bill ranging from about a 1.67 percent decrease to a 6 percent increase; and
- D. The Commission has reviewed the New Customer Rate Application and is satisfied that approval of the rate changes is appropriate.
