ORDER

WHEREAS:

- A. On December 19, 1997, Centra Gas British Columbia Inc. ("Centra Gas BC") applied to the Commission, pursuant to Sections 45 and 46 of the Utilities Commission Act ("the Act"), for a Certificate of Public Convenience and Necessity ("CPCN") to construct a 168.3 mm (6 inch) diameter high-pressure natural gas transmission pipeline lateral, at 6100 kPa (885 psig), a distance of 60 km from the Centra Gas BC main transmission pipeline at Squamish to Whistler ("the Squamish to Whistler Gas Pipeline Project"). One regulator station would be constructed at the existing Squamish, B.C. meter station site and two meter regulator stations would be constructed in the Resort Municipality of Whistler; and
- B. On December 19, 1997, Centra Gas Whistler Inc. ("Centra Gas Whistler") applied to the Commission, pursuant to Sections 45 and 46 of the Act, for a CPCN to convert propane customers' equipment to natural gas use and to retire the propane vapourization facilities in Whistler (the "Whistler Propane Conversion Project"); and
- C. The Commission, by Order No. G-8-98, set the Applications down for a pre-hearing conference which took place on February 10, 1998 in Whistler, B.C.; and

- 2. Centra Gas is to publish, in display-ad format, as soon as possible, the Notice of Public Hearing attached as Appendix B to this Order in the business sections of the Vancouver Sun and Province and in all local community newspapers in the Squamish, Whistler and Pemberton areas.

THE APPLICATIONS

- A. Centra Gas British Columbia Inc. ("Centra Gas BC") applied to the Commission on December 19, 1997, for a Certificate of Public Convenience and Necessity ("CPCN") to construct and operate a 168.3 mm (6 inch) diameter high-pressure 6100 kPA (885 psig) natural gas transmission pipeline lateral from the Centra Gas BC main transmission pipeline at Squamish to Whistler ("the Squamish to Whistler Gas Pipeline Project"), a distance of 60 km.
- B. Centra Gas Whistler Inc. ("Centra Gas Whistler") applied to the Commission on December 19, 1997, for a CPCN to convert propane customers' equipment to natural gas use and retire the propane facilities in Whistler ("the Whistler Propane Conversion Project").

THE REGULATORY PROCESS

Parties intending to participate in the proceedings are to register no later than March 23, 1998, indicating the nature of their interest and whether they propose to be full participants or interested parties. Those who have already registered need not re-register.

On February 10, 1998 the Commission held a Pre-hearing Conference on the Applications and by Order No. G-16-98, a further Regulatory Timetable summarizing the key dates for a workshop (Wednesday, March 11, 1998), information requests, response deadlines and dates for a public hearing were established.
