Re: Retail Markets Downstream of the Meter - Extension

By letter dated July 30, 1997, WKP requested a one month's extension of the July 31, 1997 filing date of the information requested by Commission letter dated May 15, 1997. This letter more fully describes the reasons for the requested extension.

WKP expects to provide loading rates, which will be incorporated in the transfer pricing policy, for services provided to non-regulated businesses. The determination of the loading rates requires an examination of accounting records which has not yet been completed. In addition, senior personnel, who should review the Code of Conduct and the Transfer Pricing Policy prior to filing, have been unavailable due to summer vacations. For these reasons, WKP has requested the one month extension.
