ORDER

WHEREAS:

SIXTH FLOOR, 900 HOWE STREET, BOX 250

- A. On November 4, 1998 Pacific Northern Gas (N.E.) Ltd., Dawson Creek Division, ["PNG (N.E.)"] filed a 1998 Cost of Service Allocation/Rate Design Study; and
- B. On December 3, 1998 PNG (N.E.) filed, pursuant to Sections 91 and 58 of the Utilities Commission Act, a 1999 Revenue Requirements Application ("the Application") for approval to increase its rates on an interim and final basis, effective January 1, 1999; and
- C. On December 16, 1998 PNG (N.E.) filed revisions to its Application revising its delivery charge calculation; and
- D. The Application as filed would result in rate increases of 18.34 percent for residential customers, 18.36 percent for small commercial customers and 12.54 percent for large commercial customers, based upon PNG (N.E.)'s forecast of gas prices in 1999; and
- E. The Commission requested PNG (N.E.) to provide an alternative gas cost calculation based upon forward market prices for 1999; and

F. PNG (N.E.) provided calculations indicating rate increases of 14.8 percent for residential customers, 14.25 percent for small commercial customers and 8.31 percent for Large Commercial Customers based

G. The Commission has reviewed the PNG (N.E.) Application and is satisfied that approval of an interim rate increase is necessary; and

H. The Commission requires that a timetable and process for dealing with the final 1999 revenue requirements application and the cost of service allocation/rate design study be established.

NOW THEREFORE the Commission orders as follows:

on the December 7, 1998 forward gas price for 1999; and

1. The Commission approves for PNG (N.E.) (Dawson Creek Division) an interim rate increase effective January 1, 1999 including gas cost changes that are based upon the December 7, 1998 forward market price for natural gas as previously provided by PNG (N.E.).

2. PNG (N.E.) is to inform all affected customers of the interim increase in rates by way of a customer notice, to be submitted in draft to the Commission for prior approval.

3. The Commission will hold a Pre-Hearing Conference on PNG (N.E.)'s Application and Cost of Service Allocation/Rate Design Study ("the Applications"), on Friday, January 15, 1999 commencing at 9:00 a.m., (10:00 a.m. in Dawson Creek), with video conferencing facilities in Vancouver, Terrace and Dawson Creek. The Pre-Hearing Conference will address procedural matters which will include, but not be limited to, the following:

- scheduling,
- completeness of the Applications,
- identification of principal issues,
- process (workshops, information requests, settlement negotiations or public hearings),
- location(s) of the proceedings, and
- other matters that will enable the proceeding to efficiently cover and review all aspects of the Applications.

4. PNG (N.E.) will publish, in display-ad format, the attached Notice of Pre-Hearing Conference in the Vancouver Sun, the Province, and in local community newspapers in its service areas by December 31, 1998.

5. PNG (N.E.) is to provide a copy of this Order, by facsimile if possible, to all Intervenors and Interested Parties registered in the 1998 PNG Revenue Requirements Application, as well as all Large Industrial Customers, as soon as possible.

6. Intervenors and Interested Parties should inform the Commission, in writing, by January 8, 1999, of their intention to intervene and/or to attend the Pre-Hearing Conference.

7. Following the results of the Pre-Hearing Conference, the Commission will issue an Order and a Regulatory Timetable to registered intervenors outlining further steps to be followed in the review of the Applications.
