- A. On December 17, 1998, Aquila Canada Corp. ("Aquila") applied to the Commission for an Agents/Brokers/Marketers ("A/B/M") Licence. On January 27, 1999, Aquila responded to a staff information request and provided the Commission with the required information and a Surety/Performance Bond in the amount of \$250,000 with Seaboard Surety Company Canada.
