## ORDER

## **WHEREAS:**

- A. On March 9, 1998, West Kootenay Power Ltd. ("WKP") filed a Transmission Access Application ("the TAA") seeking approval of wholesale transmission access and retail transmission access for its largest Industrial customers; and
- B. In the TAA, WKP requested interim approval of Tariff Supplement No. 7 (Terms and Conditions) and of rates as set out in Rate Schedules 100 to 108 for use by eligible customers seeking wholesale transmission access as defined in Tariff Supplement No. 7 (Eligible Customers), excluding customers served under Rate Schedule 31, as of March 21, 1998. WKP requested that the Commission direct that a Consultative Committee be established with a mandate as set out in Tab 10 of the Application as of the date of the interim approval; and
- C. The Commission, by Order No. G-29-98, granted interim approval of Tariff Supplement No. 7 and of rates set out in Rate Schedules 100 to 108 for use by customers seeking wholesale transmission access, effective March 21, 1998. The Commission established and subsequently held a pre-hearing conference on Friday, April 17, 1998 that was video-conferenced between Vancouver and Trail, B.C.; and
- D. As a result of input from the April 17, 1998 pre-hearing conference, the Commission by Order No. G-44-98 issued a Regulatory Timetable and required WKP to refile the TAA together with changes it considered appropriate after reviewing the Commission Decision on B.C. Hydro and Power Authority's Wholesale Transmission Services Application, by July 31, 1998; and

- E. On July 7, 1998 WKP held a consultative workshop with its eligible wholesale and retail customers in Kelowna, B.C., at which the TAA principles that it expected to file in its amended application were discussed; and
- F. On July 31, 1998 WKP refiled amendments to its TAA along with a separate application identified as the Access Principles Application ("the APA"), both for Commission approval; and
- G. The Commission reviewed the TAA and APA and issued a revised Regulatory Timetable and Notice of Public Hearing, Workshops and Negotiated Settlement by way of Order No. G-72-98, dated August 13, 1998; and
- H. The Commission has reconsidered some of the dates contained in Order No. G-72-98 and the attached Appendices, and has determined that changes are required.

## **NOW THEREFORE** the Commission orders as follows:

- 1. Order No. G-72-98 is rescinded, and is replaced by Order No. G-73-98.
- 2. The Regulatory Timetable set out in Order No. G-44-98 respecting WKP's TAA is revised to include times and locations for previously scheduled proceedings. As well, new items have been added to the Regulatory Agenda, including items related to the disposition of the APA. The revised Regulatory Agenda and Timetable is attached as Appendix A to this Order.
- 3. The disposition of the APA will proceed through the use of the ADR Negotiated Settlement process, commencing at 8:30 a.m. on September 23, 1998 at the Coast Capri Hotel, 1171 Harvey Avenue, Kelowna, B.C. If required, the ADR process will continue on September 24, 1998 at the same location. If required, a determination on the form of a subsequent public hearing will be the subject of a future Commission Order.
- 4. A public hearing into the TAA is scheduled to commence at 8:30 a.m. on October 19, 1998 at the Best Western Inn, 2402 Highway 97 North, Kelowna, B.C.
- 5. A pre-hearing workshop will be held for the APA commencing at 8:30 a.m. on September 9, 1998 at the Coast Capri Hotel, 1171 Harvey Avenue, Kelowna, B.C. A pre-hearing workshop will be held for the TAA commencing at 8:30 a.m. on September 10, 1998 at the Coast Capri Hotel in Kelowna, B.C.

- 6. A Notice of Public Hearing, Workshops and Negotiated Settlement is attached as Appendix B to this Order. WKP is required to publish the Notice as soon as possible in the business sections of the Vancouver Sun and the Province and in local newspapers in its service area, in order to adequately notify its customers. A copy of the Order is required to be sent to recent intervenors and interested parties in WKP proceedings. Parties who have already received the Applications, or who have already registered with the Commission as an Intervenor in the TAA process, need not reapply for Intervenor status in the APA process.
- 7. The Applications and supporting information are to be made available for inspection at the Head Office of WKP, 1290 Esplanade Street, Trail, B.C. V1R 4L4, and at its District Offices in:

- 10. All parties intending to apply for Participant Funding must file a budget by September 18, 1998. The budget must be consistent with the Commission's Policy and Rate Sheet as outlined in Order No. G-103-96. Copies of the Order, Policy and Rate Sheet are available upon request.

## THE APPLICATION AND REGULATORY PROCESS

West Kootenay Power Ltd. ("WKP") applied to the Commission on March 9, 1998 for approval of its Transmission Access Application ("the TAA"). The TAA proposed wholesale transmission access and retail transmission access for WKP's largest industrial customers. By Order No. G-29-98, the Commission granted interim approval of Tariff Supplement No. 7 and of Rate Schedules 100 to 108 for use by eligible customers seeking wholesale transmission access, effective March 21, 1998. By Order No. G-44-98, the Commission required WKP to refile its TAA together with changes it considered appropriate after reviewing the Commission's Decision on British Columbia Hydro and Power Authority's Wholesale Transmission Services Application. On July 7, 1998, WKP held a consultative workshop and outlined to interested parties the general parameters of its TAA. On July 31, 1998, WKP filed with the Commission amendments to its TAA and separately filed an Access Principles Application ("the APA"). The Commission has reviewed the Applications and finds that the APA should proceed by way of Negotiated Settlement. As well, the Commission has released a revised Regulatory Agenda and Timetable covering both the TAA and the APA.

The revised Regulatory Timetable amends Commission Order G-44-98 by including locations for the TAA workshop and public hearing. In addition, it establishes dates and locations for an APA workshop and Negotiated Settlement Process, along with relevant filing deadlines for both proceedings.
