Incentive Mechanism Review

ORDER

WHEREAS:

- A. On September 3, 1999, WKP filed its Preliminary 2000-2002 Revenue Requirements and Incentive Mechanism Review ("the Proposal"), requesting an Order to set rates in accordance with the Incentive Mechanism during a period beginning January 1, 2000 and ending December 31, 2002; and
- B. Commission Order No. G-94-99 set down a Workshop on the Proposal, which was held on September 29 and 30, 1999 in Kelowna B.C., followed by a Pre-hearing Conference that addressed procedural matters; and
- C. The Workshop participants agreed that an Alternative Dispute Resolution ("ADR") process be implemented with the following key dates:

Filing of Information Requests	October 6
WKP Responses to Information Requests	October 18
Filing of Preliminary Revenue Requirement Materials	November 8
Negotiated Settlement Days	November 15-17
Filing of Participant Materials for Hearing, if required	November 22
Public Hearing, if required	December 13

D. The Commission requires that an ADR regulatory process and timetable be established.
