ORDER

WHEREAS:

- A. On January 21 and February 2, 2000, Nevis Ltd. applied to the Commission for approval of housekeeping amendments to its Crude Petroleum Tariffs for the Blueberry - Taylor Pipeline ("Blueberry Pipeline") and Northeast British Columbia Pipelines ("NEBC Pipelines") effective January 1, 2000 ("the Application"); and
- B. Nevis Ltd. and predecessor companies had entered into operator/shipper agreements in 1999 and prior years to connect additional oil receiving points to the Blueberry Pipeline and NEBC Pipelines and to charge supplemental tolls; and
- C. The Application revised the current approved tolls of the Blueberry Pipeline and NEBC Pipelines to include the additional oil receiving points and supplemental tolls. Copies of the operator/shipper agreements that identified the additional oil receiving points and supplemental tolls were included with the Application; and
- D. The Commission has considered the Application and finds that approval of the tariff amendments is required.

NOW THEREFORE the Commission orders as follows:

- 1. Pursuant to Section 44 of the Pipeline Act, the Commission approves for Nevis Ltd. the following Crude Petroleum Tariff revisions effective January 1, 2000:
 - The Blueberry-Taylor Pipeline Tariff and Supplemental Toll.
 - Tariff No. 2F, Northeast British Columbia Pipelines Tariff and Supplemental Toll.

The approved tariff revisions are subject to review by the Commission following receipt of a complaint by shippers on the pipelines.

2. Nevis Ltd. is to deliver a copy of this Order and the approved tariff page revisions to all shippers on the pipelines.
