#### ORDER

#### **WHEREAS:**

- A. On June 5, 2000 the Commission, by Letter No. L-32-00, accepted BC Gas Utility Ltd.'s ("BC Gas") 2000/01 Gas Supply Annual Contracting Plan for the acquisition of gas supplies needed for the 2000/01 gas contract year; and
- B. On October 31, 2000, BC Gas filed with the Commission for acceptance, copies of Baseload, Seasonal, Peaking and other gas supply contracts and amendments for the 2000/01 gas contract year, attached as Appendices 1 and 2 to this Order; and
- C. The Commission has reviewed the BC Gas filing and is satisfied that the gas supply contracts and amendments are appropriate and in the public interest.

**NOW THEREFORE** pursuant to Section 71 of the Utilities Commission Act and the Rules for Energy Supply Contracts, the Commission accepts the following contracts and amendments for BC Gas:

- 1. New gas supply contracts for the 2000/01 gas contract year, which are listed in Appendix 1.
- 2. Gas supply contract amendments for the 2000/01 gas contract year, which are listed in Appendix 2.
- 3. The Commission accepts BC Gas' request to maintain the contracts and contract amendments as confidential.
