CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

WHEREAS:

- A. On August 29, 2001, West Kootenay Power Ltd., now known as UtiliCorp Networks Canada (British Columbia) Ltd. ("UNC"), applied to the Commission for a Certificate of Public Convenience and Necessity ("CPCN") for approval of its Intergraph Automated Mapping/Facilities Management ("AM/FM") system upgrade project, pursuant to Section 45 of the Utilities Commission Act ("the Act"). The AM/FM project will convert the existing outdated AM/FM system, and will reduce operating and maintenance expenses as well as increasing utility revenue; and
- B. The AM/FM project is expected to cost \$1.86 million, with installation, conversion of existing data and testing to be completed by May 2002; and
- C. On October 31, 2001, UNC responded to a Commission staff information request; and
- D. The Commission has reviewed the costs, timing and justification for the AM/FM project and has determined that approval of the project is in the public interest.

NOW THEREFORE the Commission orders as follows:

1. Pursuant to Section 45 of the Act, a CPCN is granted to UNC for its Intergraph AM/FM system upgrade project in accordance with the August 29, 2001 application.
