O R D E R

WHEREAS:

- A. On October 8, 2003, Terasen Gas (Vancouver Island) Inc. ("TGVI") filed with the Commission Letter Agreements for the supply of natural gas including pricing terms with Petro Canada Oil and Gas ("Petro Canada"), Coral Energy Canada Inc. ("Coral"), Husky Energy Marketing Inc. ("Husky"), Talisman Energy Inc. ("Talisman"), and Imperial Oil Resources, an Alberta Limited Partnership ("Imperial Oil"); and
- B. The Commission has reviewed the TGVI filing and is satisfied that the Agreements are in the public interest.

NOW THEREFORE the Commission Orders as follows:

1. Pursuant to Section 71 of the Utilities Commission Act and the Rules for Energy Supply Contracts, the Commission accepts for filing for Terasen Gas (Vancouver Island) Inc. the following Letter Agreements for the supply of natural gas for the 2003/04 gas contract year.
