#### ORDER

#### **WHEREAS:**

- A. On September 12, 2003, Pacific Northern Gas Ltd. ("PNG-West") filed its Third Quarter 2003 Report on Gas Supply Costs and Gas Cost Variance Account Rate Riders, pursuant to the Guidelines contained in Commission Letter No. L-5-01; and
- B. The Report projects a credit balance in the Gas Cost Variance Account ("GCVA") Rider of \$3,108,447 at September 30, 2003 for PNG-West which is projected to increase to \$5,670,087 by September 30, 2004 if customer rates remain unchanged; and
- C. PNG-West advised the Commission that it is projecting a significant revenue deficiency in 2004 and would prefer that the credit balance in the GCVA be applied to offset a potential increase in its 2004 revenue deficiency commencing January 1, 2004; and
- D. The Commission has reviewed the Report and finds that the revenue-to-cost ratio for natural gas prices in PNG-West requires an adjustment in customer rates effective October 1, 2003, pursuant to the Guidelines established by Letter No. L-5-01.

### **NOW THEREFORE** the Commission orders as follows:

1. PNG-West is ordered to file amended Gas Tariff Rate Schedules that will permit a recovery by customers of \$0.50 per GJ in the GCVA Rate Rider effective with consumption on and after October 1, 2003.
