The Commission acknowledges receipt of your letter dated September 13, 2006 (Exhibit C2-5) requesting a time extension to the filing deadline for Intervenor evidence outlined in Commission Order No. G-93-06 and seeking a ruling on whether the Reserve Allocations Order proceedings will be conducted after or concurrent with the Ministry of Energy proceedings.

The Commission Panel also acknowledges receipt of the letters dated September 21, 2006 from Counsel for Canadian Natural Resources Canada ("CNRL") supporting the request for an extension of time for filing Intervenor evidence and opposing the request from Pioneer Natural Resources Canada Ltd. ("Pioneer") that the Ministry of Energy's proceeding be held before or concurrent with the Commission's proceeding.

The Commission Panel agrees to extend the deadline for filing of Intervenor evidence to Friday, September 29, 2006.

In the interim Marauder, Talisman Energy and the Ministry of Energy should file any submissions they may have

on advisability of holding the Commission's proceedings before, concurrent with, or after the Ministry of Energy proceedings by Monday, September 25, 2006.

Pioneer & CNRL should file any reply submissions by Wednesday, September 27, 2006.

The Commission Panel will endeavor to issue its Ruling shortly after receipt of submissions.

All other items on the Regulatory Agenda will remain the same until further direction of the Commission Panel.
