**O R D E R**

**WHEREAS:**

- A. Pursuant to Section 71 of the Utilities Commission Act (the "Act") on December 13, 2006 British Columbia Hydro and Power Authority ("BC Hydro") filed with the Commission certain agreements (the "Assigning and Amending Agreements") that assign and amend Electricity Purchase Agreements and which BC Hydro processed during the three month period ending September 30, 2006 (the "Application"). The Assigning and Amending Agreements are listed in Appendix A to this Order and are more specifically identified in Schedule A ("Schedule A") of the Application; and
- B. In the Application, BC Hydro requested that the Commission keep the Assigning and Amending Agreements and attached Schedule A as confidential; and
- C. The Commission has considered the Application.

**NOW THEREFORE** the Commission orders as follows:

- 1. The Commission accepts for BC Hydro the December 13, 2006 filing of the Assigning and Amending Agreements that are set out in Appendix A to this Order as assignments of, and amendments to, Energy Supply Contracts, pursuant to Section 71 of the Act.
- 2. The Commission will keep confidential the Assigning and Amending Agreements and Schedule A of the BC Hydro Application.
