### ORDER

### WHEREAS:

- A. On December 4, 2006 MxEnergy (Canada) Ltd. ("MxEnergy") applied to the Commission for a Gas Marketer Licence. The application included the payment of the \$1,000 application fee; and
- B. On December 8, 2006 the Commission reviewed MxEnergy's \$250,000 Letter of Credit pursuant to the requirements of Item 3 of the Licence Application form; and
- C. The Commission finds that approval of the Gas Marketer Licence subject to conditions is warranted.

**NOW THEREFORE** pursuant to Section 71.1(6) of the Utilities Commission Act the Commission orders as follows:

- 1. The Commission issues to MxEnergy, a Gas Marketer Licence for the period January 11, 2007 to October 31, 2007.
- 2. The Licence is subject to the following conditions:
  - 2.1 MxEnergy will carry out the undertakings as set out in the application for a Gas Marketer Licence to market natural gas and the Rules for Gas Marketers.

- 2.2 MxEnergy will comply with the Code of Conduct for Gas Marketers and Rate Schedule 36 of Terasen Gas Inc.
- 2.3 MxEnergy will maintain a Letter of Credit or acceptable substitute in full force and effect for the duration of the Licence.
- 2.4 MxEnergy will maintain a Working Capital position of at least \$50,000 and a Current Ratio of current assets to current liabilities of at least 1.10.
- 2.5 The Commission may, at any time and without prior notice to MxEnergy, withdraw the Gas Marketer Licence for reasons the Commission, in its sole discretion, deems and considers sufficient.
- 2.6 The Gas Marketer Licence and all copies of it shall remain the property of the Commission and MxEnergy will return these documents forthwith upon written request from the Commission.
