ORDER

WHEREAS:

- A. Order E-04-06 dated May 18, 2006 approved a propane supply contract between Terasen Gas (Whistler) Inc. ("Terasen Whistler") and MP Energy Partnership ("MP Energy") for the supply of approximately 30,000,000 litres of liquid propane to the utility grid system at Whistler, B.C. for the period from April 1, 2005 to March 31, 2007, pursuant to the Commission's Rules on gas contracts and Section 71 of the Utilities Commission Act ("the Act"); and
- B. On March 15, 2007 Terasen Whistler requested approval of an Amending Agreement for the period from April 1, 2007 to March 31, 2009, which extended the terms of the propane supply agreement approved by order E-04-06 between Terasen Whistler and MP Energy for the supply of approximately 30,000,000 litres of liquid propane; and
- C. The Commission has reviewed the Amending Agreement dated March 7, 2007, between Terasen Whistler and MP Energy and is satisfied that the agreement should be accepted.

NOW THEREFORE the Commission accepts for filing pursuant to the Commission's Rules for gas supply contracts and Section 71 of the Utilities Commission Act.:

- The fully executed copy of the propane supply Amending Agreement between Terasen Gas (Whistler) Inc. and MP Energy Partnership dated March 7, 2007 for the period April 1, 2007 to March 31, 2009, for the supply of liquid propane to the Whistler propane grid system.
- The Revised Schedule A Commodity and Transportation Charges 2007/2008 and 2008/2009 from the propane supply Amending Agreement between MP Energy Partnership ("MP Energy") and Terasen Gas (Whistler) Inc. dated March 7, 2007 for the period from April 1, 2007 to March 31, 2009.

The Commission requests that Terasen Whistler file reports by July 31, 2008 and July 31, 2009 following completion of each gas year to identify the propane volumes and prices paid for winter/summer purchases including storage for the 2007/08 and 2008/09 contract periods respectively.
