WHEREAS:

- A. Pursuant to Section 71 of the Utilities Commission Act (the "Act") on January 24, 2008, British Columbia Hydro and Power Authority ("BC Hydro") filed with the Commission certain agreements (the "Amending Agreements") that amend Electricity Purchase Agreements and which BC Hydro processed during the period ending December 31, 2007 (the "Application").
