O R D E R

WHEREAS:

- A. On June 21, 2007, Letter No. L-50-07 accepted the 2007/08 Pacific Northern Gas Ltd. ("PNG") Annual Gas Contracting Plan; and
- B. On October 30, 2007 PNG filed with the Commission gas contracts for approval of the monthly and daily price premiums for gas supply arrangements that include seasonal, peaking, and storage contracts; and
- C. The Commission has reviewed the PNG filing and is satisfied that the gas supply contracts are appropriate considering market prices at the time they were negotiated and the Annual Contracting Plan for 2007/2008.

NOW THEREFORE pursuant to Section 71 of the Utilities Commission Act and the Commission's Energy Supply Contract - Rules, the Commission approves for filing the natural gas contracts shown in the Attachment A.
