O R D E R

WHEREAS:

- A. On August 26, 2009 the British Columbia Utilities Commission (Commission), by Letter L-58-09, accepted the Terasen Gas Inc. (Terasen Gas) 2009/10 Annual Gas Contracting Plan; and
- B. On March 11, 2010 Terasen Gas filed with the Commission a fully executed copy of a Gas Electronic Data Interchange (Gas EDI) Base Contract with amendments called "Standard Provisions of the Gas EDI contract for Short Term Sale and Purchase of Natural Gas General Terms and Conditions" negotiated between Terasen Gas and Sequent Energy Canada Corp. (Sequent Energy); and
- C. Terasen Gas uses the Gas EDI Base Contract dated October 26, 2000 for natural gas contracting. The Special Provisions for each gas transaction is confirmed via a deal sheet described in section 9 of the Gas EDI Standard Contract; and
- D. Terasen Gas has requested that the documents associated with the filing remain confidential due to their commercially sensitive nature as described in the filing's cover letter; and
- E. The Commission has reviewed the Terasen Gas filing and is satisfied that the Special Provisions to the Gas EDI Base Contract for Short Term Sale and Purchase of Natural Gas between Terasen Gas and Sequent Energy is consistent with the Annual Gas Contracting Plan.
