Further to your letter dated June 17, 2010 whereby the British Columbia Old Age Pensioners' Organization *et al.* (BCOAPO) requested an extension of the deadline to file Information Requests (IRs) from June 22, 2010 to June 24, 2010, the Commission Panel grants the request.

The Commission Panel notes that the deadline for Shaw to file its responses to the first round of IRs was extended and agrees that the requested extension follows. The Commission Panel also notes the consent of counsel for Shaw.
