WHEREAS:

- A. British Columbia Utilities Commission (Commission) Order G-67-09 required Entities, subject to approved Mandatory Reliability Standards, to file Mitigation Plans (MP) outlining how they plan to meet compliance with standards they were not in compliance with;
- B. By letter dated January 25, 2011, the Western Electricity Coordinating Council (WECC) recommended that the Commission approve for Powell River Energy Inc. (PREI) the dismissal (non violation) of the MP for PRC-018-1, Requirements 1, 2, 3, 4, 5, 6;
- C. By letter dated February 2, 2011, WECC recommended that the Commission approve the dismissal (non violation) of the MP for PRC-004-1, Requirements 2, 3;
- D. By letter dated February 10, 2011, WECC recommended that the Commission accept the PREI MP with a completion date of October 14, 2011 for CIP-001-1, Requirements 1, 2, 3, 4;
- E. By letter dated February 14, 2011, WECC recommended that the Commission approve the dismissal (non violation) of the MP for PRC-001-1, Requirements 1, 2, 5;
- F. By letter dated February 17, 2011, WECC recommended that the Commission approve the dismissal (non violation) of the MP for IRO-005-2, Requirements 9, 17;

- G. By letter dated February 25, 2011, WECC recommended that the Commission accept the MP for PRC-001-1, Requirement 3 with a completion date of October 14, 2011;
- H. By letter dated March 4, 2011, WECC recommended that the Commission approve the dismissal (non violation) of the MP for IRO-005-2, Requirement 13;
- I. The Commission has considered the recommendations put forward by WECC for PREI.

NOW THEREFORE pursuant to section 125.2 (10) of the *Utilities Commission Act*, the Commission accepts the WECC recommendations and approves the mitigation plans as listed above.
