ORDER

WHEREAS:

- A. On November 29, 2013, Pacific Northern Gas Ltd. (PNG) filed its 2014 Revenue Requirements Application with the British Columbia Utilities Commission (Commission) pursuant to sections 58 to 61 of the *Utilities Commission Act* (UCA) seeking, among other things, Commission approval to increase delivery rates (2014 RRA);
- B. British Columbia Old Age Pensioners' Organization (BCOAPO) registered as an Intervener in the proceeding;
- C. By Order G-31-14, dated March 12, 2014, the Commission established a Negotiated Settlement Process for the review of the 2014 RRA, and by Letter L-20-14 dated May 20, 2014, the Commission issued an Amended Regulatory Timetable;
- D. On July 7, 2014, BCOAPO filed an application for Participant Assistance/Cost Award (PACA) for the 2014 RRA in the amount of \$11,175.15 (BCOAPO PACA Application);
- E. By Order G-87-14 dated July 9, 2014, the Commission approved the Negotiated Settlement Agreement;
- F. On August 22, 2014, PNG advised the Commission that it has no comments on the BCOAPO PACA Application;
- G. The Commission has reviewed the BCOAPO PACA Application with regard to the criteria and rates set out in the PACA Guidelines in Commission Order G-72-07 and finds the requested amount reasonable.
