## WHEREAS:

- A. On November 17, 2014, the Insurance Corporation of British Columbia (ICBC) submitted to the British Columbia Utilities Commission (Commission) an application to amend multiple sections of the Basic Insurance Tariff (Tariff), with a proposed effective date of January 1, 2015 (Application);
- B. On December 9, 2014, ICBC filed revisions to the original Application (Revised Application);
- C. ICBC is proposing amendments to the following Tariff pages:
  - Car Share (Schedule B, page 36)
  - Cement Mixers (Schedule B, pages 1 and 78)
  - Limousines (Schedule B, pages 59, 61, 63, 67, and 68)
  - Schedule R Header (Schedule R, pages 1, 2, and 3);
