**Re: Review of 2010 Certificate of Public Convenience and Necessity
Application Guideline and the Project Reporting Process and Purposes**

By Letter L-41-14 dated August 8, 2014, the British Columbia Utilities Commission (Commission) sought comments on recommendations stemming from the Stage 2 Prudency Expenditure Inquiry for the Kettle Valley Distribution Source Project Decision and on a draft 2015 Certificate of Public Convenience and Necessity Application Guideline (Guideline).

The Commission received comments from:

The Commission thanks all those who have provided their comments to date. In Letter L-41-14, the Commission stated it may request a second reply comment to help resolve any outstanding issues. BC Hydro and the CEC noted that an opportunity to provide reply comments with consideration for other parties' comments would be beneficial.
