**O R D E R**

**WHEREAS:**

- A. On February 26, 2015, British Columbia Hydro and Power Authority (BC Hydro) filed with the British Columbia Utilities Commission (Commission) pursuant to sections 58 to 61 of the *Utilities Commission Act*, an application for approval of Electric Tariff Supplement No. 85, a Special Contract between BC Hydro and FortisBC Inc. (FBC) for the supply of electrical service under BC Hydro's Electric Tariff (Application);
- B. BC Hydro and FBC have negotiated the Special Contract, to be known as Electric Tariff Supplement No. 85, for the purpose of enabling the ongoing supply of electricity to BC Hydro's Blizzard Mountain Microwave Repeater Station;
- C. BC Hydro submits that no other parties other than FBC and BC Hydro are affected by this arrangement;
- D. FBC has agreed to the terms and conditions of the Special Contract and, by letter dated February 27, 2015, has submitted a letter of support for this Application; and
- E. The Commission reviewed the Application and considers that approval is warranted.
