ORDER

WHEREAS:

- A. Section 125.2 of the *Utilities Commission Act* (UCA) assigns exclusive jurisdiction to the British Columbia Utilities Commission (Commission) to determine whether a "reliability standard," as defined in the UCA, is in the public interest and should be adopted in British Columbia. By Order G-123-09, the Commission approved the Compliance Monitoring Program (CMP) for monitoring and enforcement of adopted reliability standards and appointed the Western Electricity Coordinating Council (WECC) as its Administrator for registration and monitoring compliance as per section 8 of the UCA. WECC's role as Administrator for the BC MRS Program was renewed in the first amended Administration Agreement, dated August 21, 2014;
- B. Pursuant to section 5 of the CMP, an entity subject to approved Mandatory Reliability Standards found in Confirmed Violation of a reliability standard must prepare a Mitigation Plan (MP) to correct the Confirmed Violation or prepare a description of how the Confirmed Violation has been mitigated. An MP with respect to a Confirmed Violation must be submitted to the Administrator within ten business days following confirmation by the Commission;
- C. An MP with respect to an Alleged Violation may be submitted at any time and the Commission encourages entities to mitigate all perceived instances of noncompliance upon detection;
- D. On October 6, 2014, Catalyst Paper Crofton Division submitted an MP (Version 1) to address the alleged violation of Reliability Standard PRC-017-0R1 with the proposed completion date of February 3, 2015;
- E. By email notification dated March 10, 2015, WECC recommended acceptance of the following MP to bring Catalyst Paper Crofton Division into compliance with the Reliability Standard identified below:
